It's time to Swim!!

Monday April 18th – 6:30p-8:30p

Who needs to take the swim Qualification Test???

Everyone; PARENT'S, LEADER'S AND SCOUT'S take the test if you:

- **Canoe on the Brule River this June**
- **Go to Many Point Scout Camp this Summer**
(You can test at camp when you get there, but we like to have our testing done prior to camp if possible. No one; Scouts, Leaders, Adults can swim at camp without taking the test.)
- **Go swimming with the Troop during the year**

When: Monday April 18th from 6:30p – 8:30p

We will start at 6:30 with an assembly line style retest for scouts First Class and above or adults that have previously qualified as Swimmer. All first year Boy Scouts, those that have not passed Swimmer, and those that find the swimmer test to be a challenge can arrive after 7 for a more personally administered swim test. We have open swim following the assembly line retests until 8:30.

Where: Lafayette Club Swimming Pool - 2800 Northview Rd, Minnetonka Beach, MN 55361

Cost: \$5/ per person - Cash or Check due at the pool - *Please bring exact amount*

Swimming Classifications (3 Groups) and Testing Requirements

Non-Swimmers - Have not passed a Swim Qualification Test.

Beginners

- Jump feet first into the water over head in depth.
- Level Off Swim 25 Feet on the surface
- Stop
- Turn Sharply
- Resume Swimming as before return to starting place.

Swimmers

- Jump feet first into the water over head in depth.
- Level off Swim 75 Feet in a strong manner using sidestroke, breaststroke, trudgen or crawl. (Can use combination of strokes)
- Then Swim 25 Yards using and easy resting backstroke
- Then 100 yards must be swum continuously and include at least 1 sharp turn.
- After completing the swim, rest by floating.
